

Double Reward Terms and Conditions (1 March - 31 March 2025)

These Terms and Conditions ("Terms") apply to Altify's **Double Reward Promotion** ("Promotion"). By participating in this promotion, you agree to be bound by these Terms.

- 1. The Double Reward Promotion is open to referring individuals who meet the following criteria:
 - a. Must be an existing customer of our company and have an active account.
 - b. Must have a unique referral code generated by our system when you sign up for an account.
- 2. The referrer can refer friends to Altify by sharing their unique referral code or by allowing their friends and family to scan the QR code on their app.
- 3. The referee must use the referrer's unique referral or QR code during the sign-up process to be eligible for the bonus.
- The referee must verify their account and make one initial investment of at least R500, £25, €25 or \$25 into a single product for the referrer and the referee to qualify for the bonuses.
- 5. Referrer Bonus: If the referee signs up using the referrer's unique referral code and makes an investment of at least R500, £25, €25 or \$25 into a single

product, the referrer will receive a bonus of 150 Rewards Points (worth R300, \pm 15, \in 15 or \$15) credited to their account.

- Double Reward additional bonus: The referrer will receive an additional R300, £15, €15 or \$15 deposited straight into their Altify account for every successful referral made between 1 March - 31 March 2025.
- 7. In order to qualify for your additional bonus, your referred friend must keep their investment active on the platform until the end of March 2025.
- The additional cash bonus will be credited to the referrer's account within the first week of April 2025, provided that the referee meets all required conditions.

- 11. The referee can only be referred by one referrer, and the referee can only use one unique referral code during the sign-up process.
- 12. Our company reserves the right to modify, suspend, or terminate the program at any time without prior notice.
- 13. In case of any violation of these terms and conditions or any fraudulent activity, our company reserves the right to disqualify the referrer and/or referee from receiving any bonuses.
