

# **Plus2 Promotional Terms**

23 July - 12 September 2025

These Terms and Conditions ("Terms") apply to **Altify's 2% cash bonus promotion** ("Promotion"). By using this Promotion or otherwise participating in the Promotion, you agree to be bound by these Terms.

#### **The Promotion**

Here's a simple breakdown of our 2% cash bonus promotion.

#### What's the offer?

A 2% cash bonus on your first qualifying investment or crypto deposit.

#### Who is it for?

New Altify customers who sign up and make their first deposit between 23 July and 12 September 2025.

#### How do I get it?

Sign up with the code Plus2, fund your account, and hold your initial investment for 90 days.

The bonus is calculated on your first investment from cash into crypto, **OR** your first crypto deposit. We'll pay it out in your local currency (ZAR, USD, GBP, or EUR).

The cash bonus will be paid directly into your Altify account within five business days after a 90-day holding period.

## How to Qualify in 3 Steps

# Step 1

#### Sign up with the promo code

Create your new Altify account and enter the code **Plus2** during registration. This promotion is for new customers only.

# Step 2

#### Make your first deposit and investment

The bonus is calculated on your very first qualifying transaction.

This can be either:

- A cash investment: Deposit cash (ZAR, USD, etc.) and invest it into any cryptocurrency, Crypto Bundle, commodity, or stablecoin. The bonus is based on the amount you invest.
- A crypto deposit: Deposit any cryptocurrency from an external wallet or exchange.
  The bonus is based on the market value of the crypto when it arrives in your Altify account.

The minimum qualifying amount is R1,000 (or its equivalent). The maximum is R100,000, for a total bonus of up to R2,000.

#### Step 3

## Hold your investment for 90 days

You must keep the full value of your initial qualifying investment or crypto deposit on the Altify platform for a continuous 90-day period.

You can sell out of any investment or deposit and trade as much as you like. However, if you withdraw these funds before the 90 days are up, you will no longer be eligible for the bonus.

## A few examples:

#### • Example 1

You deposit R10,000 and invest the full amount in Bitcoin. Your 2% bonus is calculated on R10,000.

## • Example 2

You deposit R50,000 worth of Ethereum. Your 2% bonus is calculated on R50,000.

## • Example 3

You deposit R10,000 but only invest R5,000 in crypto. Your 2% bonus is calculated on the R5,000 you invested.

Your bonus is calculated on your *very first* transaction only. Any later investments or deposits won't count towards this promotion.

Your bonus amount is locked in at the time of your transaction and won't change if the value of your investment goes up or down.

#### **Getting Your Bonus**

Once the 90-day holding period is complete, we'll pay the cash bonus directly into your Altify account within five business days. We'll send you an email to let you know it's there.

You can then reinvest the cash or withdraw it.

# **Receiving Your Bonus**

We'll pay the bonus directly into your Altify account within five business days after your 90-day holding period ends.

We'll send you an email and a notification to let you know it's there. You can then reinvest it or withdraw it to your bank.

#### **Forfeiture & Cancellation**

If you withdraw your initial funds or transfer them to another platform before the 90-day holding period is over, you will lose the bonus.

We expect everyone to use this promotion fairly. Creating duplicate accounts or trying to game the system will result in your account being closed and any bonuses being removed.

Altify reserves the right to cancel this promotion at any time. However, if you've already qualified before any cancellation, we will honour our agreement with you.
