



## Fee Free Promotional Terms

6 October - 17 October 2025

These Terms and Conditions (“Terms”) apply to Altify’s fee free promotion on **Nvidia (NVDAX), Tesla (TSLAX), Coinbase (COINX), Robinhood (HOODX), and Circle (CRCLX)** (“Promotion”). By participating in this Promotion, you agree to be bound by these Terms.

1. This Promotion is available exclusively to customers who purchase **Nvidia (NVDAX), Tesla (TSLAX), Coinbase (COINX), Robinhood (HOODX), or Circle (CRCLX)** using eligible fiat currencies (South African Rand [ZAR], Great British Pounds [GBP], US Dollars [USD]).
2. **Important:** Customers located in the European Union (EU) will not have access to tokenised stocks and cannot participate in this Promotion.
3. No other product exchange will be eligible for no fees when purchasing **Nvidia (NVDAX), Tesla (TSLAX), Coinbase (COINX), Robinhood (HOODX), or Circle (CRCLX)**. For example, **USD Tether (USDT) to Nvidia (NVDAX)** transactions will incur a fee as usual.
4. The sale of **Nvidia (NVDAX), Tesla (TSLAX), Coinbase (COINX), Robinhood (HOODX), or Circle (CRCLX)** into USDT or fiat currencies will incur the standard fee applicable to your account.
5. This Promotion commences at **00:00 SAST on the 6th of October 2025** and concludes at **23:59 on the 17th of October 2025**. All requirements of these Terms must be met within that timeframe to qualify.

6. If you are an existing Altify customer, you must log in to your account, make a deposit, and purchase **Nvidia (NVDAX), Tesla (TSLAX), Coinbase (COINX), Robinhood (HOODX), or Circle (CRCLX)** with (South African Rands [ZAR], Great British Pounds [GBP], or US Dollars [USD] within the promotion timeframe to take advantage of this Promotion.
7. If you are not currently an Altify customer, you will need to download the Altify app to sign up for an account [here](#), verify your identity and submit all the documentation required. Verifications can take up to 48 hours to be processed, so it is important to verify your account as soon as possible to ensure your account will be active during this Promotion.
8. Once your identity is successfully verified, you will get an email from us letting you know that your verification is complete, and that your account is active. If there is any missing or incorrect documentation, your account may take longer to verify. If this is the case, one of our support staff will be in touch with you to assist in getting your verification completed.
9. On successful completion of your verification, you will be able to participate in this Promotion provided that the Promotion has not ended.
10. We would love to see you continue investing with us after you activate your Promotion. Note that regular transactional and withdrawal fees will apply. For more information, please refer to the [fees](#) section on our website.
