The Basics

1. What's in these terms?

These terms tell you the rules for using our website www.altify.app (our site).

2. Who we are and how to contact us?

Our site is operated by Altiy Group Ltd (we or us). We are registered in England and Wales under company number 11713189 and have our registered office at Suites 3 to 5, Fulham Business Exchange, the Boulevard, London, England, SW6 2TL.

We have subsidiaries that are regulated in the EU and South Africa.

Altify EU is registered as a VASP in Poland and appears on the Polish VASP register bearing KRS Number 0001030633 and NIP Number 7252330350.
- Altify SA Capital (Pty) Limited ("Altify Capital") is an authorised financial services provider (FSP) and Crypto Asset Services Provider (CASP) in the Republic of South Africa with registration number 52727.
- Altify SA DAS (Pty) Limited ("Altify DAS") is an authorised Crypto Asset Services Provider (CASP) with registration number 53289.

Use of the website

3. By using our site you accept these terms

By using our site, you confirm that you accept these terms of use and that you agree to comply with them

If you do not agree to these terms, you must not use our site.

12. Our responsibility for loss or damage suffered by you

Whether you are a consumer or a business user:

We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors and for fraud or fraudulent misrepresentation.

15. Which country's laws apply to any disputes?

You and we both agree that the courts of England and Wales will have exclusive jurisdiction except that if you are a resident of Northern Ireland you may also bring proceedings in Northern Ireland, and if you are resident of Scotland, you may also bring proceedings in Scotland.

If you are a business, these terms of use, their subject matter and their formation (and any non-contractual disputes or claims) are governed by English law. We both agree to the exclusive jurisdiction of the courts of England and Wales.
