### The Basics

#### 1. What's in these terms?

These terms tell you the rules for using our website [www.altify.app](http://www.altify.app) (our site).

#### 2. Who we are and how to contact us?

Our site is operated by Altify Group Ltd (we or us). We are registered in England and Wales under company number 11713189 and have our registered office at Suites 3 to 5, Fulham Business Exchange, the Boulevard, London, England, SW6 2TL.

We have subsidiaries that are regulated in the EU and South Africa.

- Coinpanion Crypto Services Sp. z o.o. ("**Altify EU**") is a Virtual Asset Service Provider (VASP). Altify EU is a private company incorporated in the Republic of Poland. Altify EU is registered as a VASP in Poland and appears on the Polish VASP register bearing KRS Number 0001030633 and NIP Number 7252330350.
- Altify SA Capital (Pty) Limited ("**Altify Capital**") is an authorised financial services provider (FSP) and Crypto Asset Services Provider (CASP) in the Republic of South Africa with registration number 52727.
- Altify SA DAS (Pty) Limited ("**Altify DAS**") is an authorised Crypto Asset Services Provider (CASP) with registration number 53289.

#### 3. By using our site you accept these terms

## **Our Responsibilities**

### **12. Our responsibility for loss or damage suffered by you**

#### **Whether you are a consumer or a business user:**

We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors and for fraud or fraudulent misrepresentation.

Different limitations and exclusions of liability will apply to liability arising as a result of any services we provide to you, which will be set out in our Terms of Service (as applicable).

#### **If you are a business user:**

- we exclude all implied conditions, warranties, representations or other terms that may apply to our site or any content on it,
- we will not be liable to you for any loss or damage, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, even if foreseeable, arising under or in connection with:

You must not attack our site via a denial-of-service attack or a distributed denial-of service attack. By breaching this provision, you would commit a criminal offence under the UK's Computer Misuse Act 1990. We will report any such breach to the relevant law enforcement authorities and we will co-operate with those authorities by disclosing your identity to them. In the event of such a breach, your right to use our site will cease immediately.

### **14. Rules about linking to our site**

### Extra Legal Information

#### **15. Which country's laws apply to any disputes?**

If you are a consumer, please note that these terms of use, their subject matter and their formation, are governed by English law. You and we both agree that the courts of England and Wales will have exclusive jurisdiction except that if you are a resident of Northern Ireland you may also bring proceedings in Northern Ireland, and if you are resident of Scotland, you may also bring proceedings in Scotland.

If you are a business, these terms of use, their subject matter and their formation (and any non-contractual disputes or claims) are governed by English law. We both agree to the exclusive jurisdiction of the courts of England and Wales.
